ADMISSION NOTIFICATION

1. Notification for Non-CUET FYUGP Admissions (2026–27)

- Final Registration-cum-Spot Admission: **4 August to 7 August 2026**
- Orientation Programme: **10 August 2026**
- Commencement of First Semester Classes: **11 August 2026**

2. Eligibility for Admission (Non-CUET Category)

- Candidates must have **passed the Higher Secondary (10+2) Examination or its equivalent** from a recognized Board/Council.
- Candidates must satisfy the **programme-specific eligibility criteria** prescribed by Gauhati University and adopted by the College for the respective Major/Minor discipline.
- Admission shall be **purely subject to merit, availability of seats, reservation policy, and fulfilment of all eligibility conditions** prescribed by the Government of Assam, Gauhati University, and the Directorate of Higher Education, Assam.
- Applicants must complete registration and programme selection through the **Assam SAMARTH Admission Portal** within the notified schedule and produce the required original documents at the time of admission.
- Candidates are advised to carefully verify the **programme-specific eligibility requirements** before applying, as notified in the College Prospectus/Information Bulletin.

3. Notification for Lateral Entry, 2026

- Only for admission to the **3rd, 5th and 7th Semesters** under the NEP-2020 Multiple Entry–Exit provisions.
- Registration: **27 July–4 August 2026**
- Scrutiny: **5–6 August 2026**
- Admission: **7–8 August 2026**

4. Important Guidelines for Lateral Entry Applicants

- Lateral entry is **not** applicable for normal semester progression or re-admission to the same programme in the same institution.
- Applicants must have passed all papers of the **2nd, 4th or 6th Semester**, as applicable.

- Applications must be submitted through the **Assam SAMARTH Lateral Entry Portal**.
 - Students should verify the admission policy and eligibility criteria of the institution before applying.
5. A candidate shall be eligible to apply for Lateral Entry if he/she:
- is a **currently enrolled student** in a Four-Year Undergraduate Programme under NEP-2020;
 - has **successfully passed all papers** of the:
 - 2nd Semester** for admission to the **3rd Semester**;
 - 4th Semester** for admission to the **5th Semester**; or
 - 6th Semester** for admission to the **7th Semester**.
 - Accurately furnishes the existing enrolment number, Major subject and other required particulars while submitting the online application.
 - Fulfils the programme-specific eligibility requirements prescribed by Gauhati University and Vidya Bharati College.
 - Verifies the admission policy and eligibility criteria of the receiving institution before applying.

- Offline/manual migration for lateral entry is **not permitted**.
- Admissions under Multiple Entry–Exit and Horizontal Mobility shall be processed only through the designated Assam SAMARTH Lateral Entry Portal.
